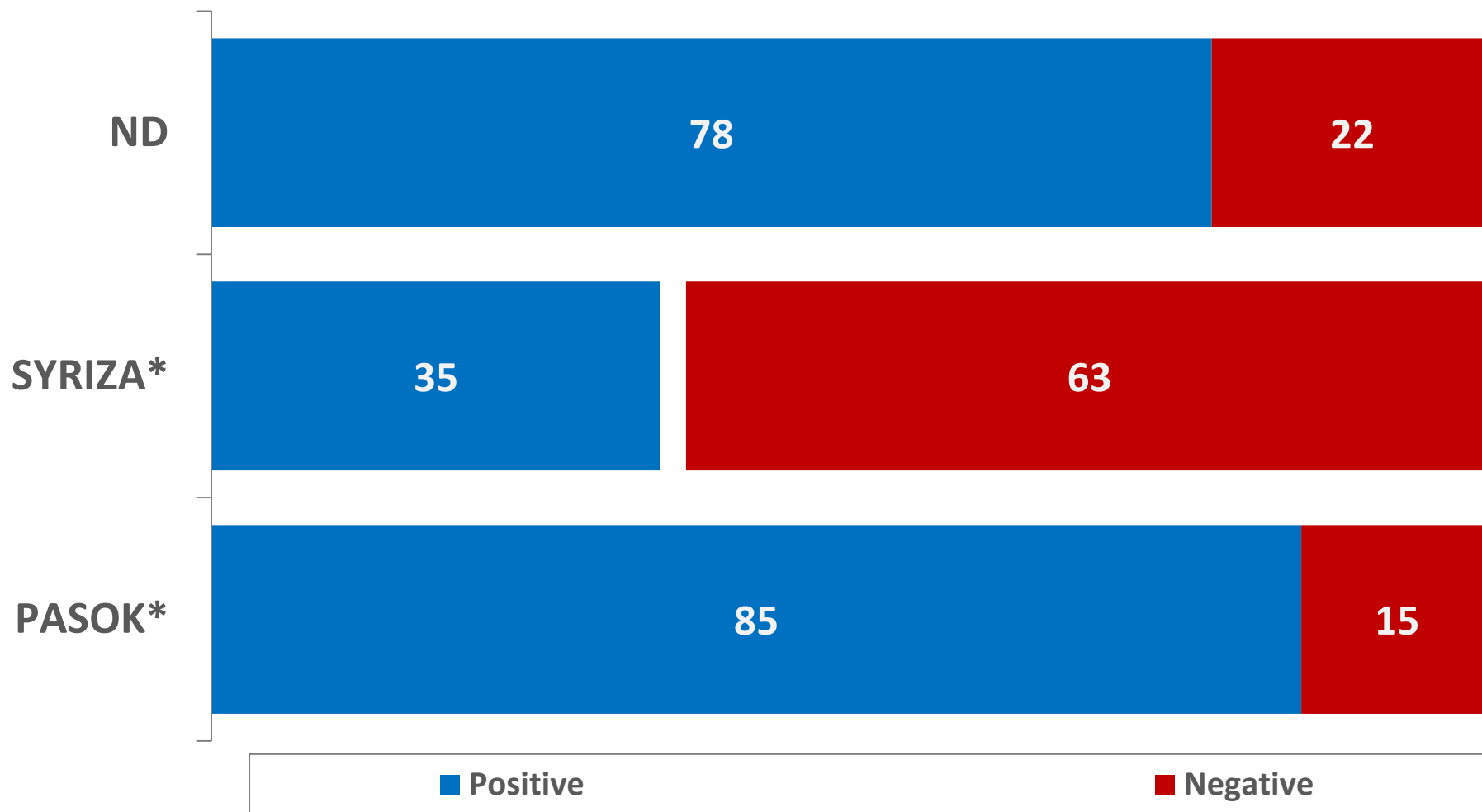

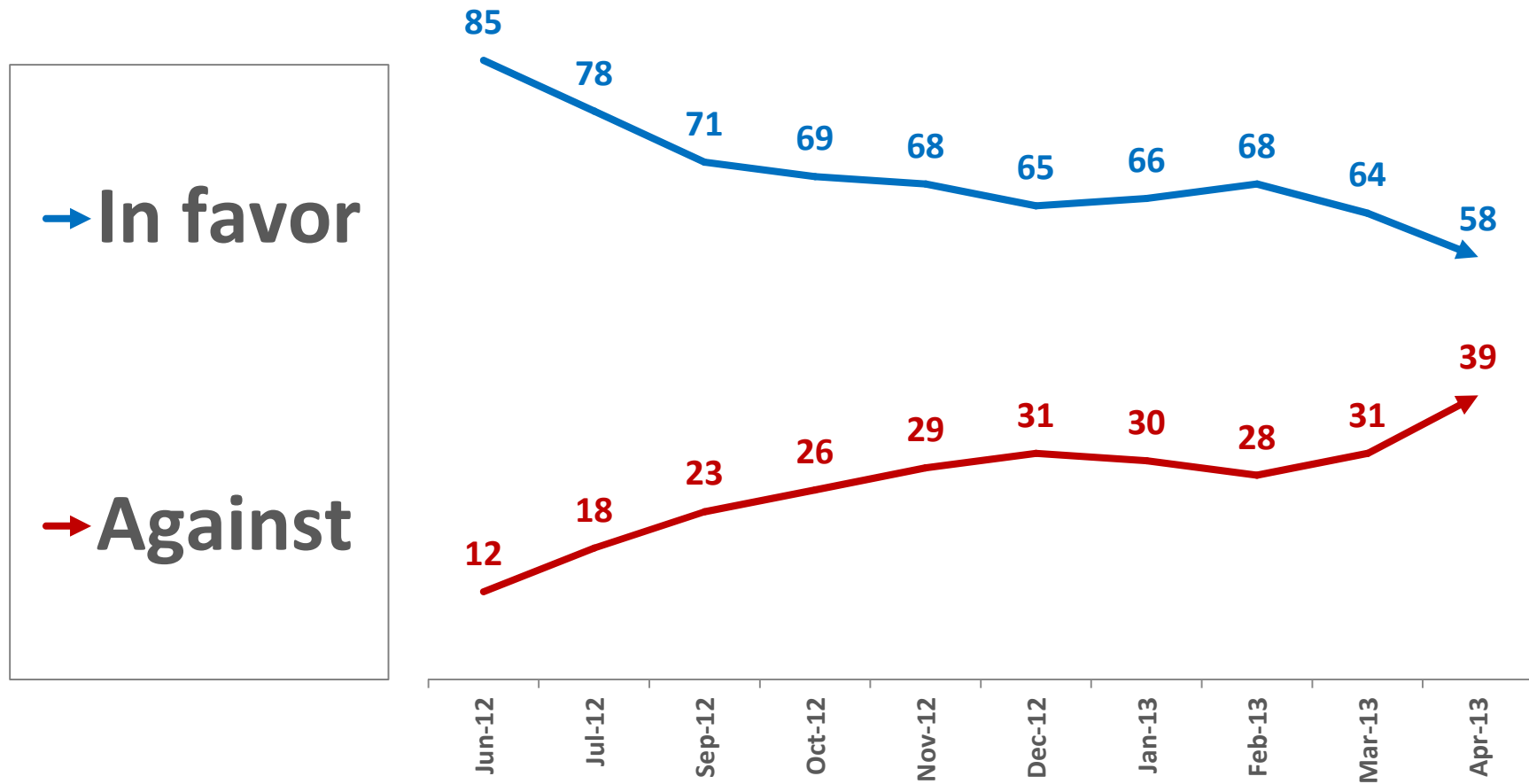

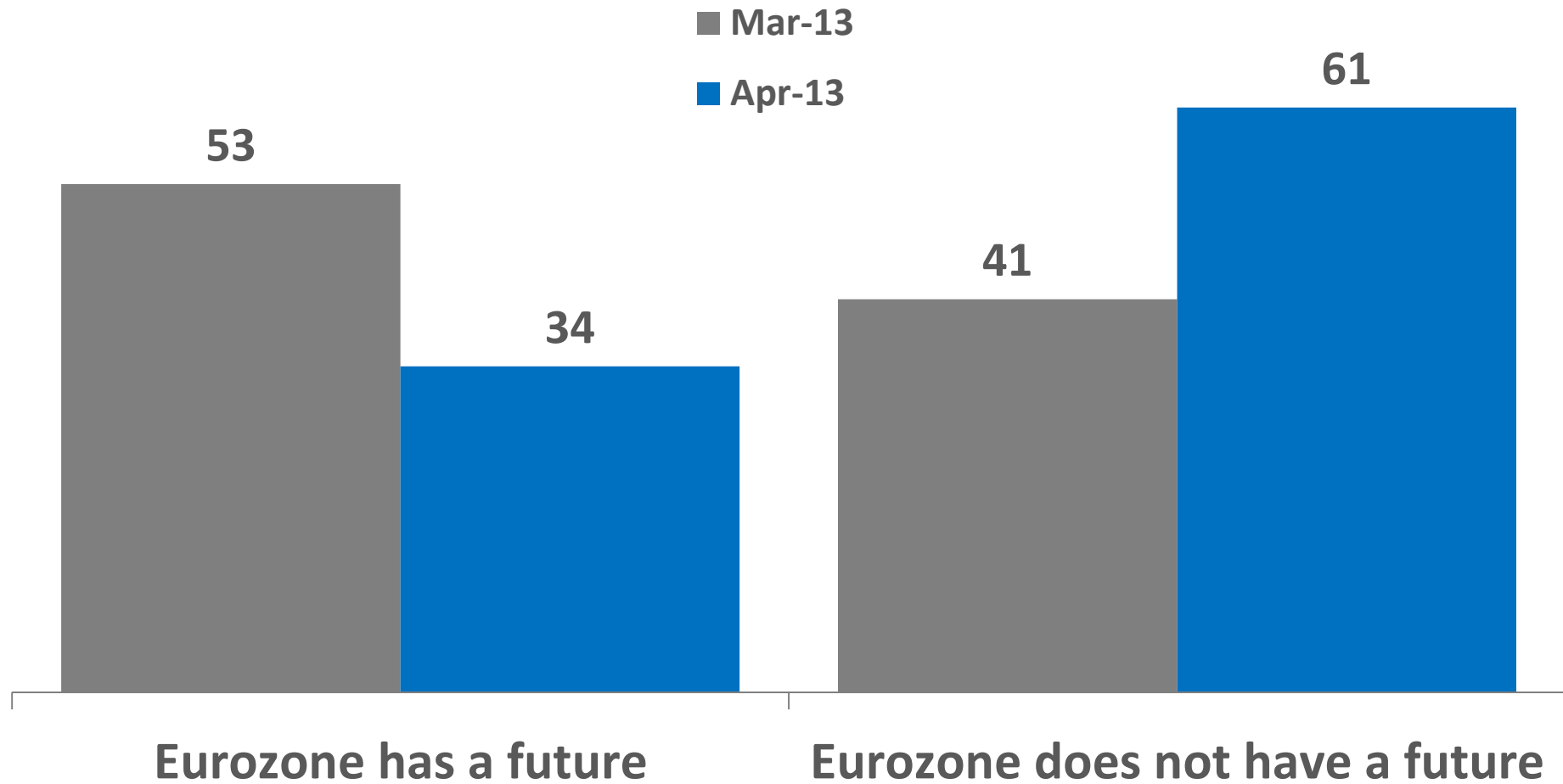

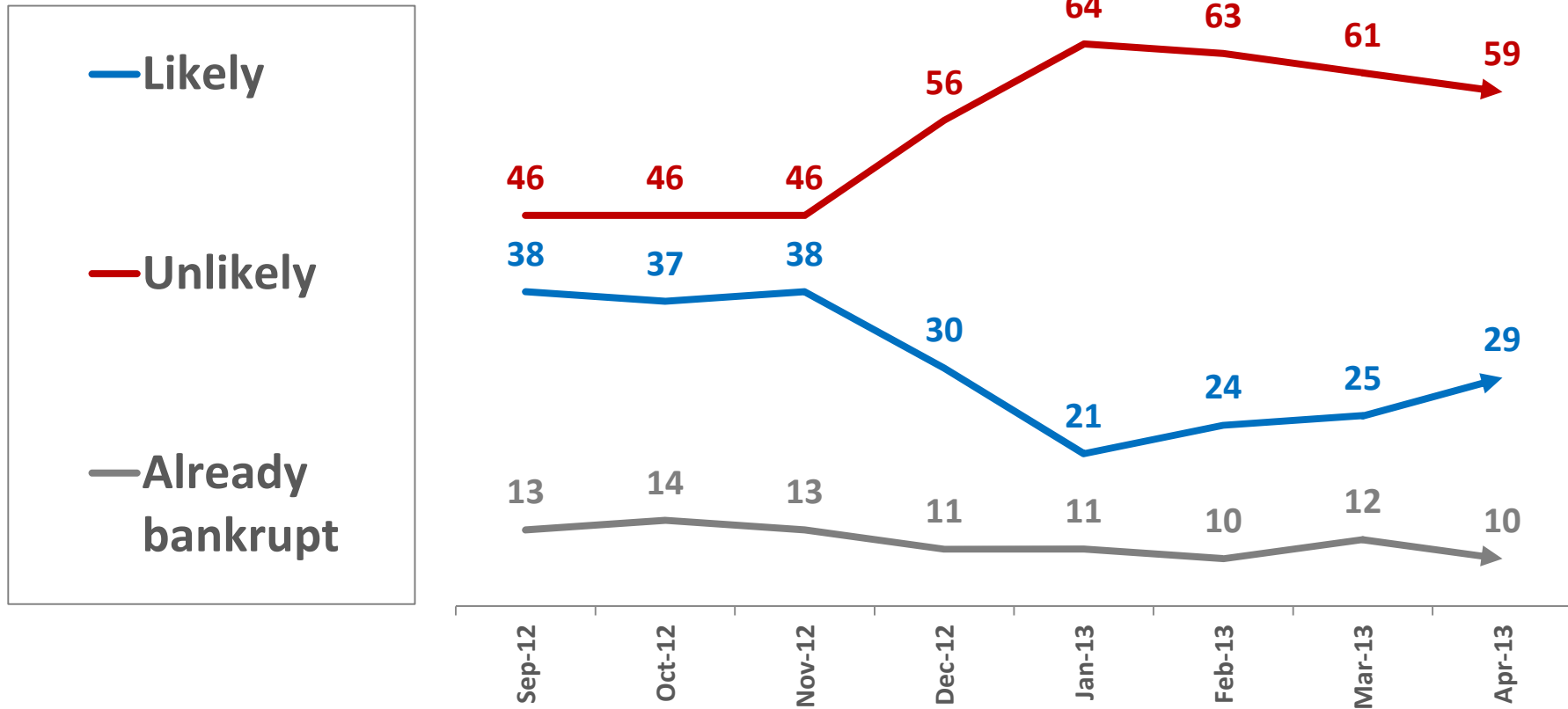

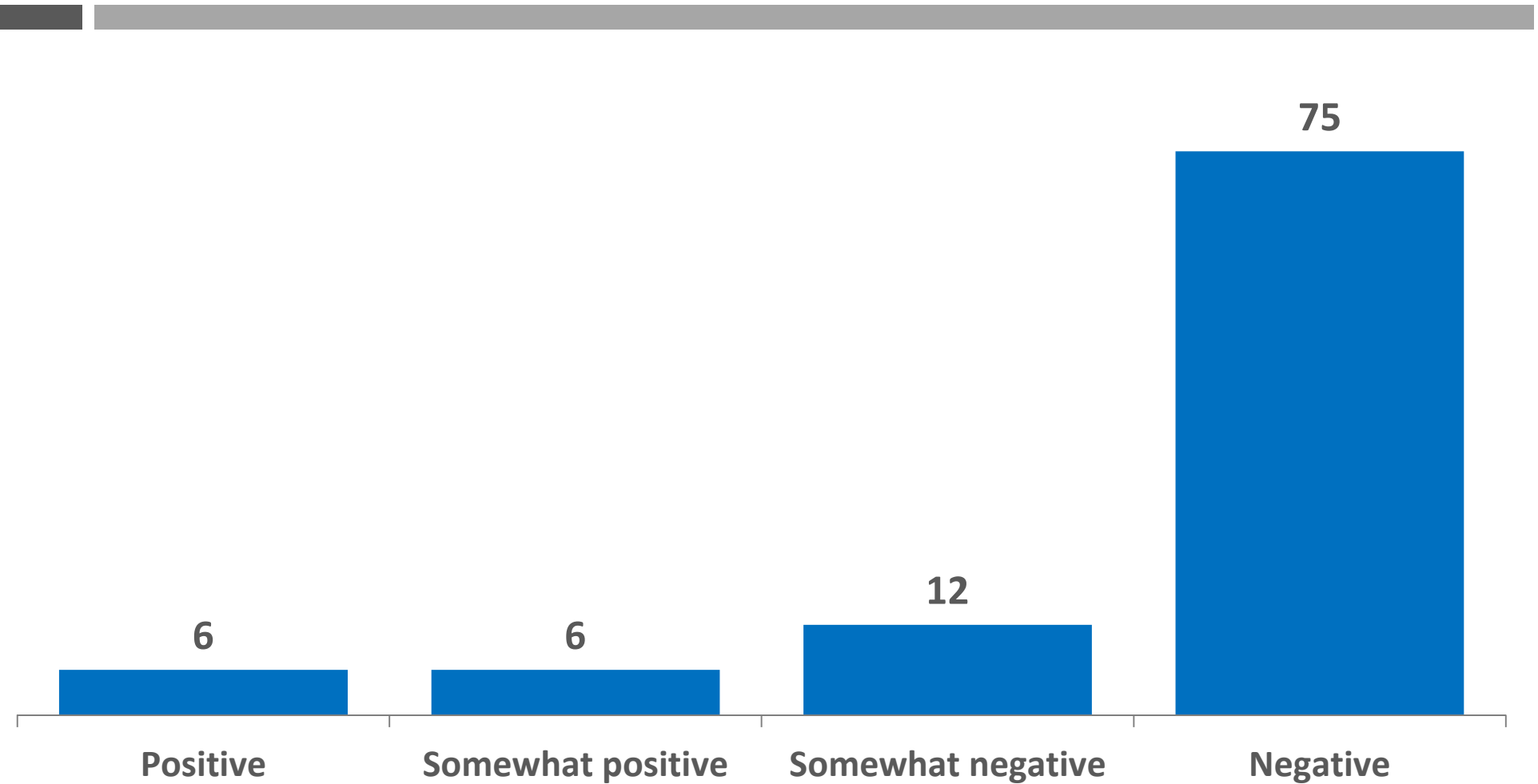

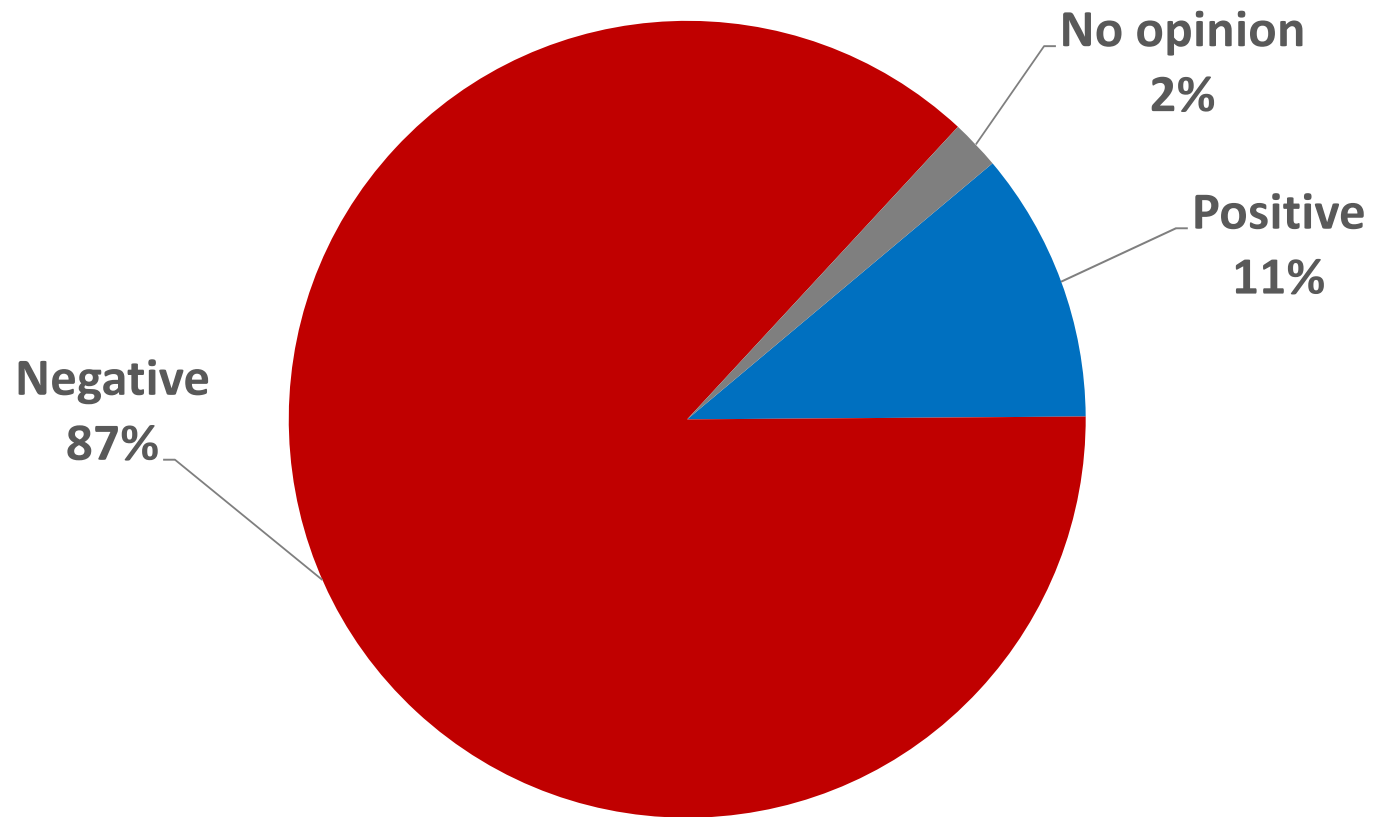

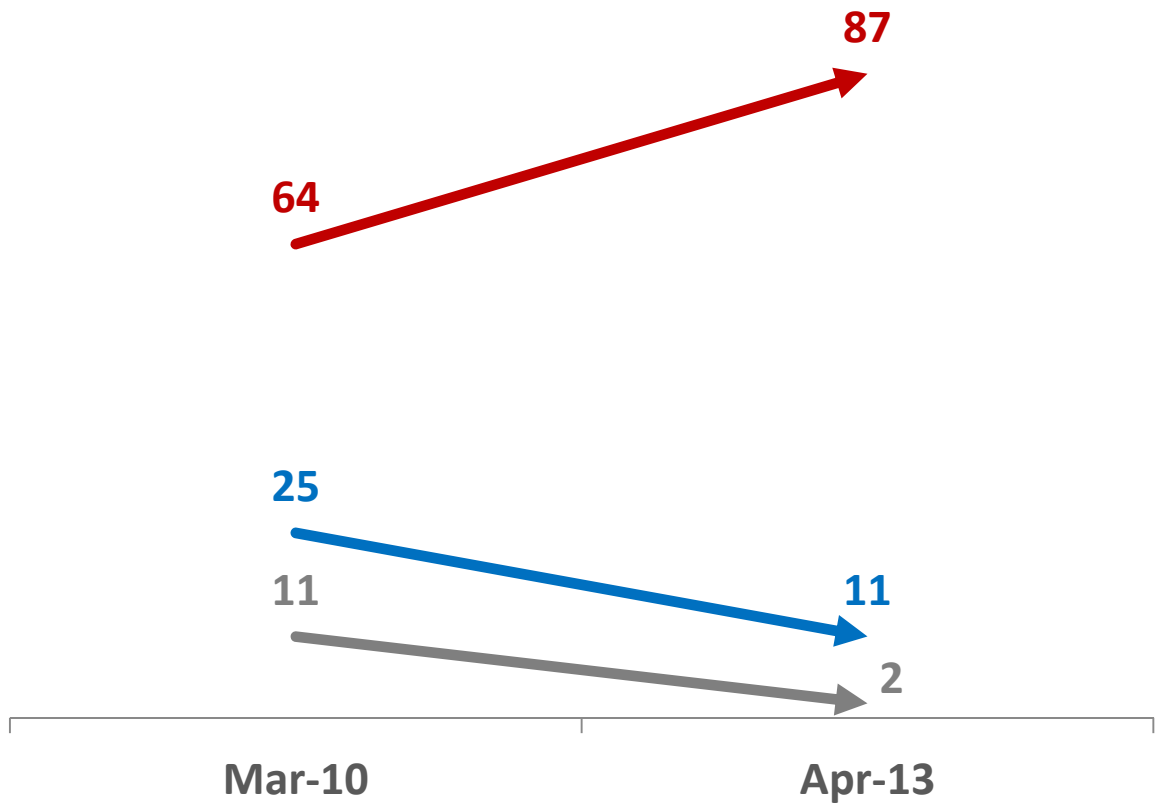

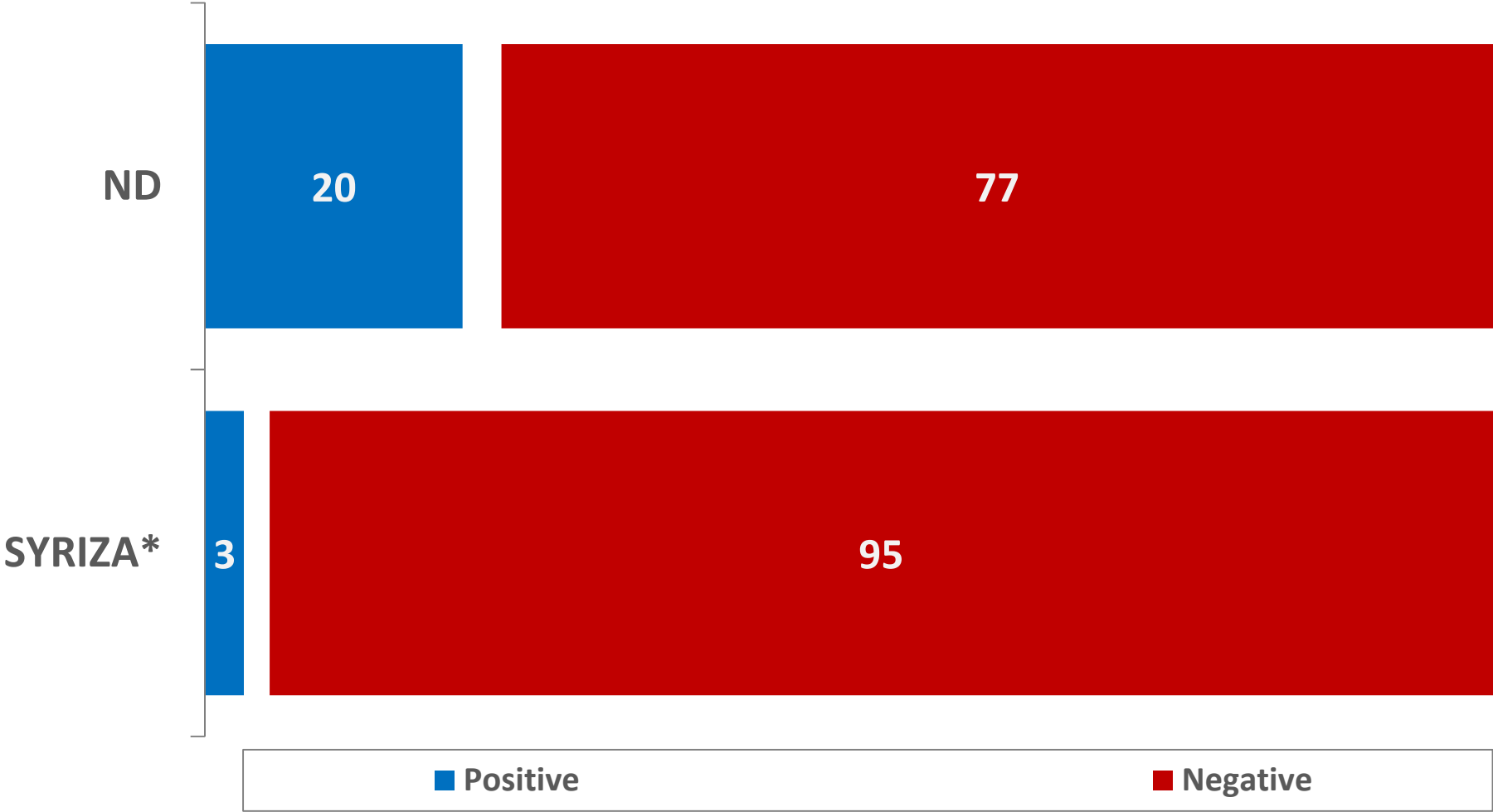

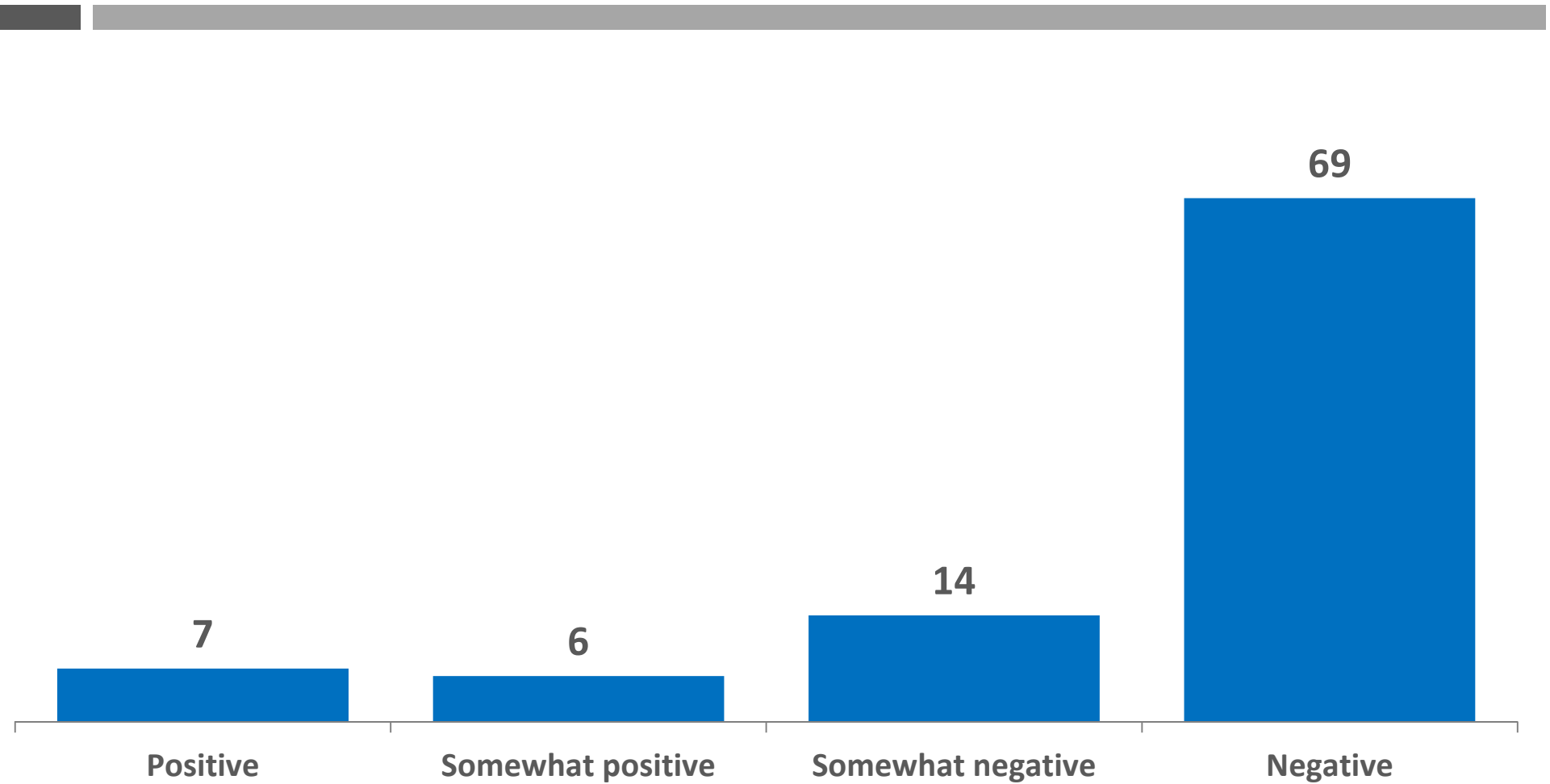

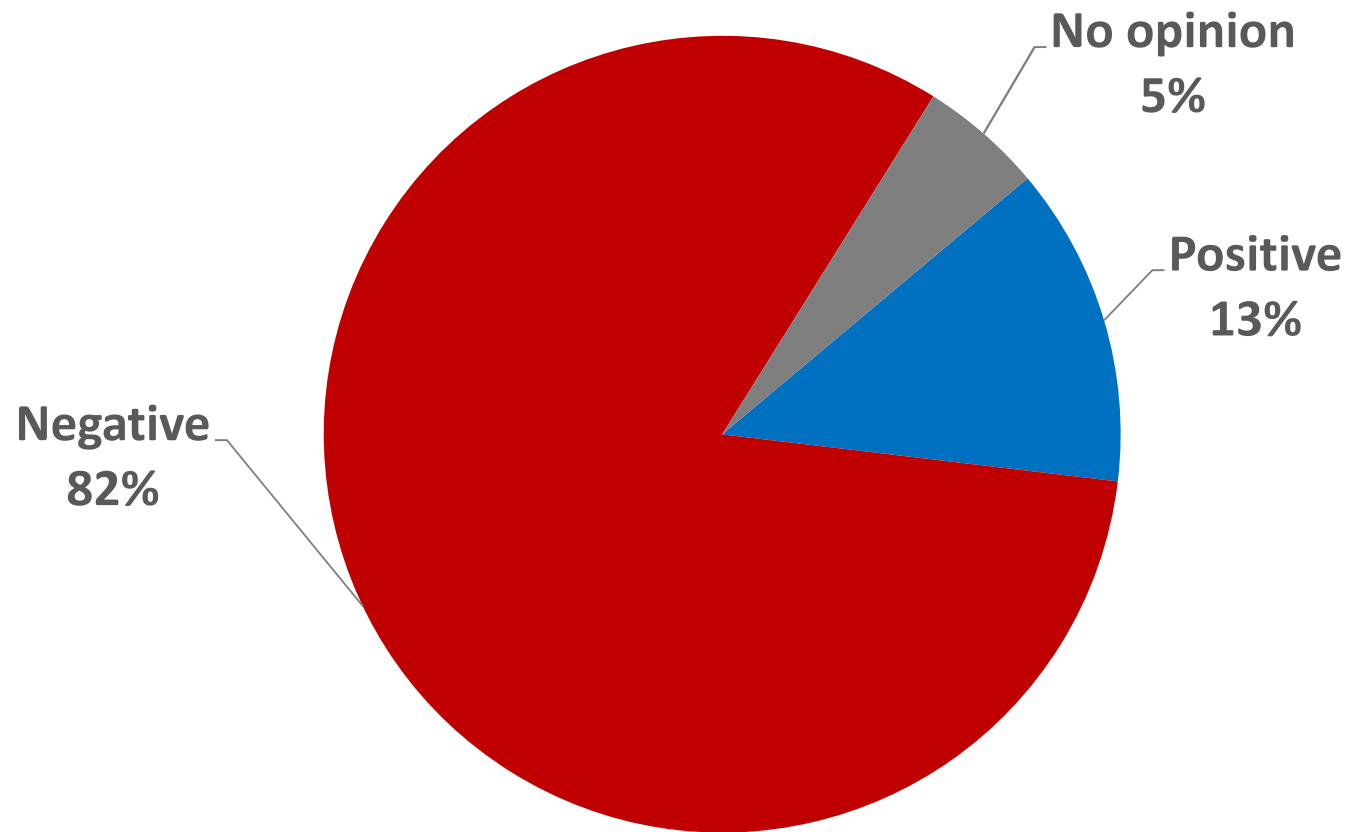


11. POPULARITY OF WOLFGANG SCHÄUBLE

What is your opinion of Wolfgang Schäuble?



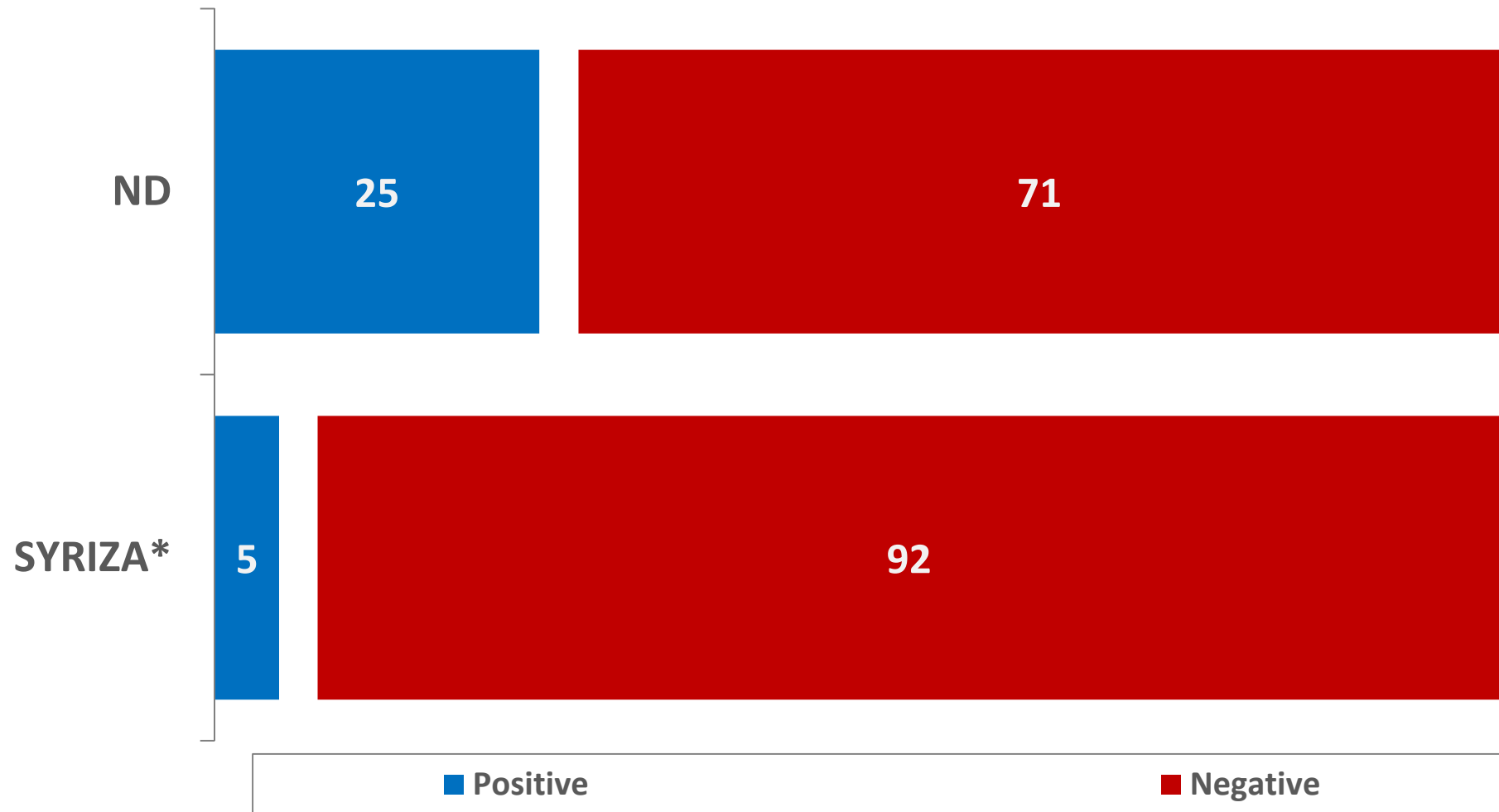

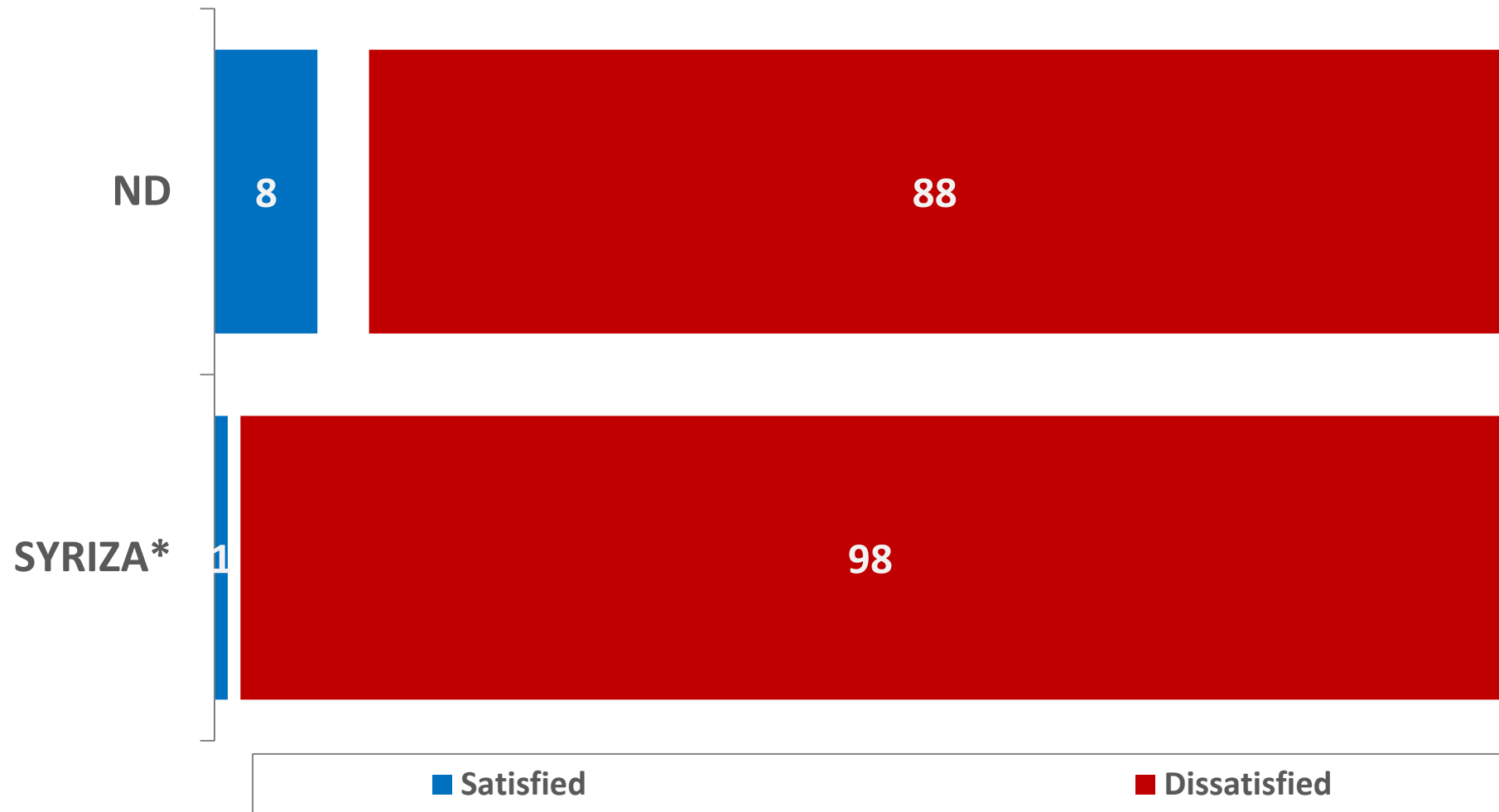

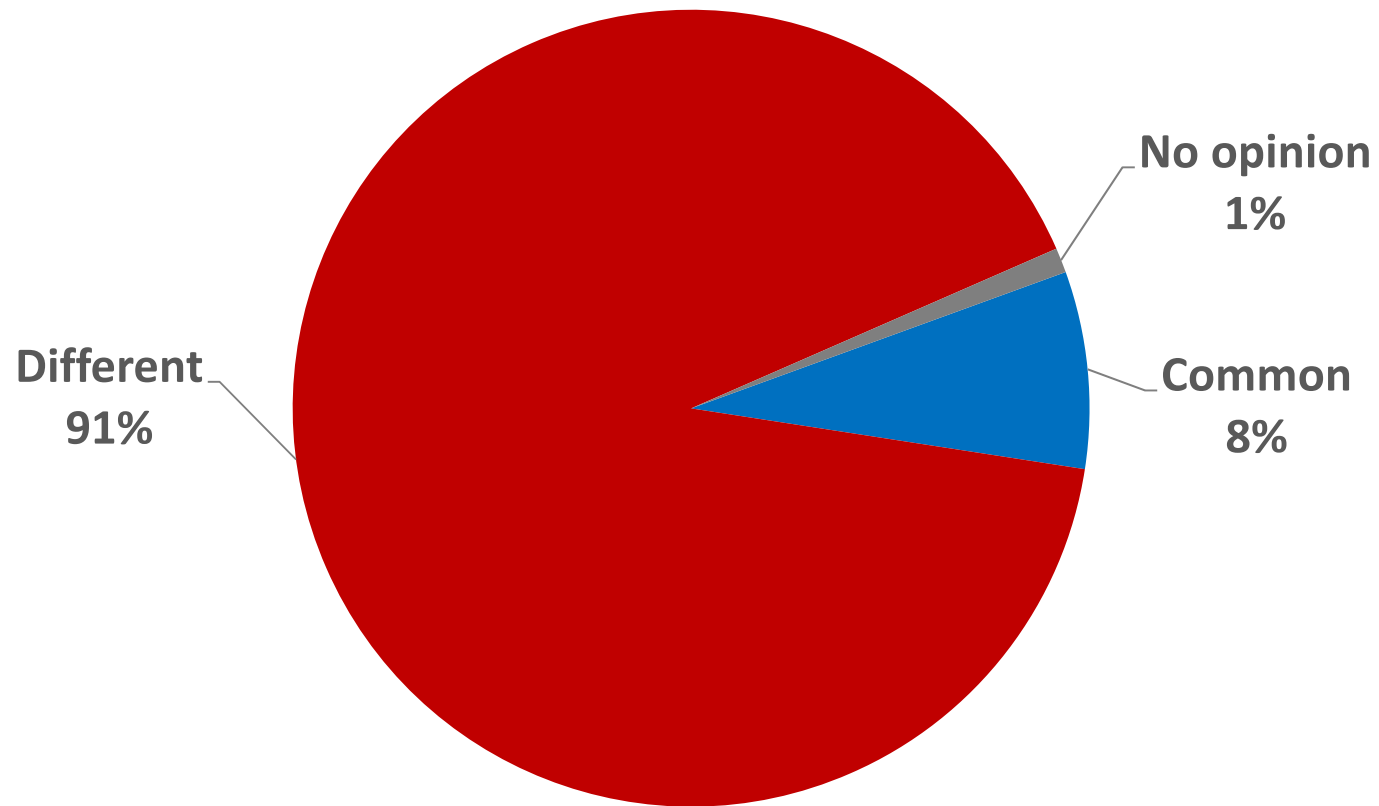

SURVEY PROFILE

COMPANY:

PUBLIC ISSUE

TYPE & METHOD:

Quantitative survey conducted by telephone interviews based on a structured questionnaire

POPULATION:

General population aged 18 and over

AREA:

Nationwide

SAMPLE:

The sample size is 1.033 people. The split sample technique was used in the questions of the diagrams 1-5 & 7-18.

PERIOD:

5-9/4/2013

SAMPLING METHOD:

Multi-stage, stratified

STANDARD ERROR:

+/- 3.2% at a confidence interval of 95%.

The sampling error for the variables that were measured with the split sample technique (½ of the sample) is +/- 4,4%.

INTERVIEWERS:

33 interviewers and 2 supervisors

NOTE:

Due to rounding, some distributions may not add up to 100%
